

## FPICOT3260 RECOVER 4WD VEHICLES

### COURSE OVERVIEW

This unit covers the competency required to recover 4x4 vehicles in difficult terrain and a variety of work settings. This includes using different vehicle jacks in different terrains and environmental conditions. Using a winch and a snatch block (2:1) in difficult terrain, using ground anchor points in a range of terrain types that reflect local conditions. Using other types of recovery equipment in a safe and efficient manner and to demonstrate competency and consistency of performance.

### PRE-REQUISITES

### DURATION & MODE OF DELIVERY

2-3 Days Dependent upon student aptitude, the quantity of course participants and weather conditions. This course is conducted face to face, including classroom based theory and off road practical components.

- You must understand and speak the **English language** at a level that enables the safe operation of a 4WD vehicle
- You must supply your **current drivers licence**
- You are required to wear comfortable and practical clothing and enclosed footwear and bring steel capped boots.
- PPE will be provided on the day, however if you have or have access to leather gloves or a high visibility vest or shirt, please bring them with you.
- All students are required to obtain a **USI** number prior to attending a Nationally Recognised Training course, see our website homepage for further information <http://www.1stopdrivingschool.com.au/index.html>
- Tea & Coffee is provided, please arrive 10 minutes prior to the commencement of training.
- All course participants will be provided with a **student handbook** detailing their rights and responsibilities.

## CERTIFICATION

This course is Nationally Recognised Training and applicants' deemed competent at the conclusion of the course will be provided with a Statement of Attainment.



## PAYMENT & TRADING TERMS

All courses require a position holding deposit of 50%. Applicants will be advised of the amount at the time of the booking. Students have the right to appeal if they are not satisfied with the outcome, according to your rights and responsibilities detailed in the student handbook. Further fees may be applicable for participants that require reassessment.

## CANCELLATION & WITHDRAWALS

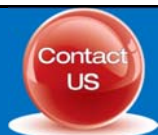
In the event of cancellation or withdrawal from this course a minimum of 72 hours' notice is mandatory. 10% of the deposit will be retained by 1 Stop Driving School for administration fees, the remainder of the deposit will be returned to the original payer.
